CHIEF'S REPORT

E3414 is on its way to General Fire in Spokane today for replacement of the both the left and right 6-inch butterfly valves that stick when opening. This work will be completed under warranty.

The fall newsletter is completed and will be sent to Fire District #4 citizens next week. A copy was presented to the board.

The Department Christmas Party and Light parade is scheduled for December 2nd @ 3pm. Would like to have Elves in the Christmas parade, and make Santa's Workshop the theme.

Testing for a Captains eligibility list is December 5th and 6th. Closing for applications ended yesterday. We have 4 members who submitted applications.

Truck annuals are underway and moving along as scheduled. The goal is to have all annuals completed by the end of December.
