APPROVAL OF AGENDA

SECRETARY'S REPORT

The March Commissioners activity reports were reviewed and approved by each commissioner.

CHIEF'S REPORT

March Fire and EMS incidents, 99 total. Staying consistent at 70% EMS and 30% Fire.

An offer to Justin Folz has been accepted with a May 1, start date. Laelen Torrance started April 1, going through orientation. Laelen, Justin and Wyatt will move to shift around June 1, when orientation is complete. Then Laelen, Justin and Viorel will attend ARFF school when we are able to schedule in Helena.

Backing incident with Engine E3411 backing into Duty officer's vehicle on a critical call.

Rescue 3441 back door was replaced by Northwest Collision.

New E3441 is in service at station 41. Old E3441 will be renumbered to E3445 and moved to station 45. Our goal is to have E3442 in service in June.

New Type 1 Engine will be ready for inspection the first of May. Chiefs Golden and McKinney are planning to complete the inspection. A discount will be available if paid within 30 days of delivery.

An extend-o-bed and canopy have been ordered for Utility 348. General Fire revised the estimate to complete the upfitting.

Credit Cards have been updated. No changes to the cards. One card for Brandon McKinney and one travel card through Banner Bank. Chief Golden will have a Costco Citi Card.
